Section 1. Records and Audits. The Board of Managers shall keep or cause to be kept detailed records of the actions of the Board of Managers, minutes of the meetings of the Unit Owners and financial records and books of account of the Association, including a chronological listing of the receipts and expenditures and a separate bookkeeping account for each Unit which, among other matters, shall contain the amount of each assessment of common charges against each Unit, the date when due, the amounts paid thereon and the balance remaining unpaid. A written report summarizing all receipts and expenditures of the Association shall be given by the Board of Managers to all Unit Owners at least semi-annually. In addition, an annual report of the assets and liabilities, including receipts and expenditures of the Association, shall be delivered by the Board of Managers to all Unit Owners and to all mortgages of Units who have requested the same, within sixty (60) days after the end of each calendar year.
